Admission fee: \$25

Dues: \$150 per quarter. Due on the first day of January, April, July and October or an annual fee of \$600 per year due January 1. Dues include Rotary International Membership, Sunrise Rotary Membership, Rotarian magazine, and breakfast prior to weekly meetings.

Membership Process: Applicants must be sponsored by a Sunrise Rotary member in good standing. The completed application should be submitted to the Club Secretary. The Board will ensure the proposed new member meets all the classification and membership requirements of the Rotary Constitution and will approve or disapprove the proposed member within 30 days of the application. Upon Board approval, the proposed member's name will be announced to the membership and included in the minutes. If no written objection is submitted by a member of the Club within seven (7) days, the proposed member, upon payment of the admission fee, will be considered to be elected to membership. An induction ceremony will follow at the next regularly scheduled meeting. If a written objection is submitted, the Board will vote again to approve or disapprove the application.

Who We Are: Sunrise Rotary of Walla Walla is a non-profit organization affiliated with Rotary International and organized within Rotary District #5080. The Object of Rotary is to encourage and foster the ideal of service as a basis of worthy enterprise. Sunrise Rotary supports international projects such as Polio Plus, the volunteer arm of the global partnership dedicated to eradicating Polio. We have provided financial support to well drilling projects in undeveloped countries, to Rotaplast, a program that provides life-changing improvements to hundreds of underprivileged children and young adults with cleft lips and palates. We also have provided support to ShelterBox, an international program to provide disaster relief. Many of our members are Paul Harris Fellows, an award based on their significant contributions to the Rotary Foundation.

On a local level, Sunrise Rotary's primary focus has been on youth. We often contribute to youth athletic programs in the community as well as programs that assist underprivileged children. We award annual memorial college scholarships. In addition, the club performs a semi-annual cleanup of two miles of Highway 12, and we also coordinate special projects including the purchase and construction of a "play fort" at Fort Walla Walla Museum and playground equipment and walking paths at Vista Terrace Park, 920 Mountain Park Drive in Walla Walla.
